# Summary description

A strip of horse-grazed pasture extending from a narrow floodplain up a southwest facing valley side. The sward is mainly short with a diverse range of neutral grassland plants. Grassland fungi occur on the drier parts. Scattered scrub occurs throughout the area. The lower area includes a shallow meander channel with wetland vegetation.

# Qualifying features

Neutral grassland with at least 8 indicator species.

# Secondary features

Scrub.

Stream.

# Potential value/ unconfirmed features

The stream corridor is likely to be used by Otters.

The area is likely to be of value to foraging bats.

Additional species of grassland fungi are likely to be present.

The scrub margins are likely to provide a habitat for reptiles.

# Current management (including problems and opportunities for biodiversity enhancement)

Horses graze the fields, which appears to be at an optimal level for a good range of wildlife. Limited scrub clearance may be of value for biodiversity where dense Bramble is present on the drier ground. Grazing is heaviest in the northern field, which has relatively low plant diversity, which may still be good for grassland fungi. Japanese knotweed occurs beside the stream but is kept in check by the livestock. New Zealand Pigmyweed (*Crassula helmsii*) is abundant in the old meander channel.

#### Access/ community use

There are no public footpaths through the site.

#### Additional information

This site lies immediately adjacent to the River Sirhowy SINC NH 3.11 along its southwestern boundary and SINC NH 3.71 Blackwood Riverside Woodlands along its southeastern boundary. The grassland to the west of the stream may also be of value for biodiversity and should be considered for inclusion at future SINC review.


Grassland fungi on the drier slopes included Hygrocybe coccinea, H.intermedia, H.conica, H.glutinipes and Entoloma sp.

Fauna observations: Rabbit, **Song Thrush, Bullfinch, Green Woodpecker,** Meadow Brown Butterfly.

<u>Additional species noted from desk study and consultation</u>: **Otter** (on river less than 50m from boundary), Carex caryophyllea, Leontodon autumnalis, Polygala vulgaris, Potentilla anglica, Ranunculus bulbosus, Sanguisorba officinalis.
