FULL DESCRIPTION OF SITE	(including t	topography, a	djacent land	use, access and boundaries etc.):		

This is a rectangular orchard that slopes gently downwards to the N.E.. The orchard is within rough grassland that is usually grazed for part of the year by sheep but has been left, then mown this year. The grassland is not particularly species rich but Knapweed (Centaurea nigra) and Red Clover (Trifolium pratense) are noticeable. Hedgerows form much of the boundary of the site with a fence dividing off the N.E, end of the orchard which is under different ownership (not known so not part of LWS) and management (manure appears to be stored here). There are a good number of old/veteran fruit trees present, these are mostly Apples but there are also a few pears present including rare varieties that are named after this orchard (Berllanderi Green and Berllanderi Red). The older trees are generally present towards the perimeter of the orchard. The veteran trees have many good veteran tree features including dead wood and hollow trunks. Dead wood on the ground is more limited but some is remaining. The remaining veteran trees appear in reasonably good health. Two new rows of trees have been recently planted (mostly Pear), these have involved grafting from the existing veteran trees.




