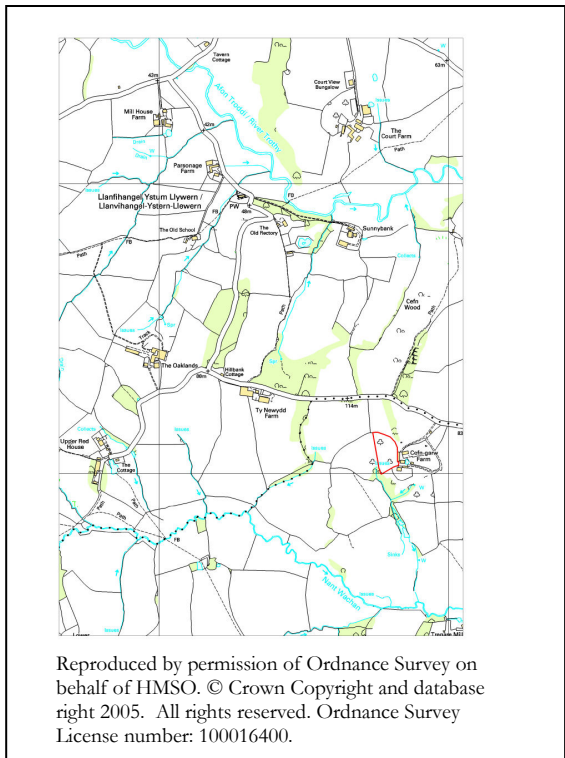

### FULL DESCRIPTION OF SITE (including topography, adjacent land use, access and boundaries etc.):

The orchard is to the west of Cefn-garw Farmhouse. It is on an area of grazed, improved grassland that is largely flanked by hedgerows. It is partially stock-proof. The land slopes downwards from both the east and west to reach a low point in the middle where a dry ditch is present. The orchard comprises Apples and one Damson. All the trees are old with some missing (compared to 2005 aerial photos), some dead, some fallen but alive and a few still in apparently good health. Many of the dead trees are left in-situ and there is no new planting. There are many veteran tree features but the orchard appears to be on “its last legs”.

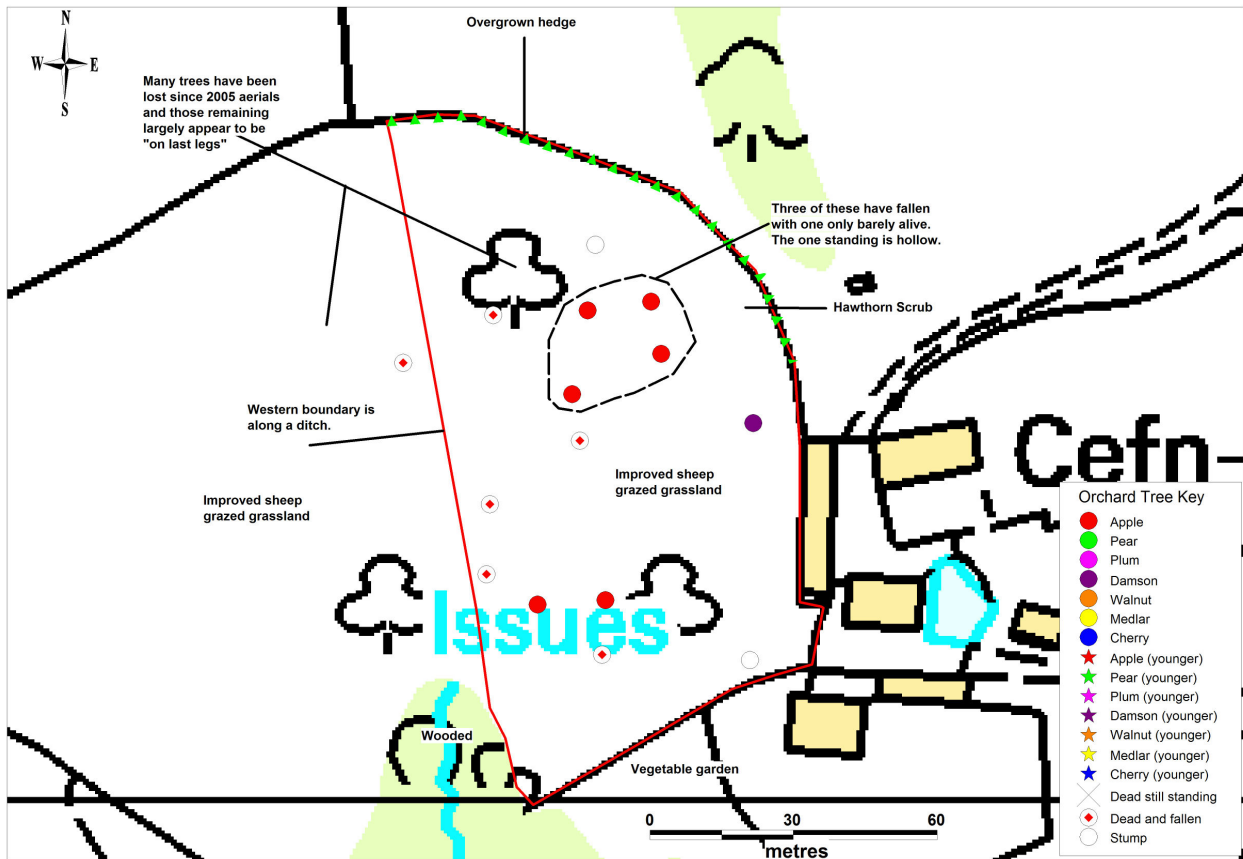
