This is a large orchard divided in two by a historically laid hedge. Fishpool woods lies to the north with hedgerows surrounding all other sides. Beneath the trees is rank grassland which is not very species rich but contains many Ant Hills of good size. The orchard contains many Apple trees throughout the orchard with the planting perhaps slightly more dense in the eastern side. The trees are of a reasonable age/size and seem to all be of a similar age but have not yet attained veteran age so veteran tree features are quite limited although some small hollows and bits of dead wood are present. Most trees appear in good health but there are occasional dead trees which have fallen (these are left in-situ and


