

**FULL DESCRIPTION OF SITE (including topography, adjacent land use, access and boundaries etc.):**

This is a small orchard, that was formerly a cider orchard that now forms part of the garden to “Garth”. The orchard floor which slopes downwards to the north is grassy and mown. A number of very old Apple trees are present with dead wood apparent. Plum trees are also present, together with a number of none fruit trees. There is a hedgerow to the north but most of the orchard is open to the rest of the garden that accompanies the house. \*Survey not very detailed as owners had people arriving so survey was very brief and orchard not entered properly.
