FULL DESCRIPTION OF SITE				

The orchard is located within rough pasture that slopes downwards to the north and west. The orchard is grazed on occasion by a small number of rescue ponies. It is bordered by wire fencing with electric fence also bisecting the site. The grassland is relatively species poor with patches of thistles and nettles, the west side which has slightly steeper sloping, west facing slopes has frequent ant-hills and species such as Autumn Hawkbit are frequent together with a number of other herbs such as Catsear, Red Clover and Yarrow. The orchard is well covered with fruit trees, which are all Apple, with one very large Cherry and a more recently planted Plum. The apple trees are all of a similar age (40 years) but have many veteran tree features including dead wood in the canopy, and hollow trunks. Many of the trees are also festooned in Mistletoe. It should be noted that the majority of the trees have wire mesh, barbed wire attached/imbedded in them as this has not been removed once the tree has become established, this may have accelerated the formation of dead wood/hollows in the trunks. Despite this the trees are largely in good health although a few have been lost in recent years. Dead wood is largely left in-situ.


