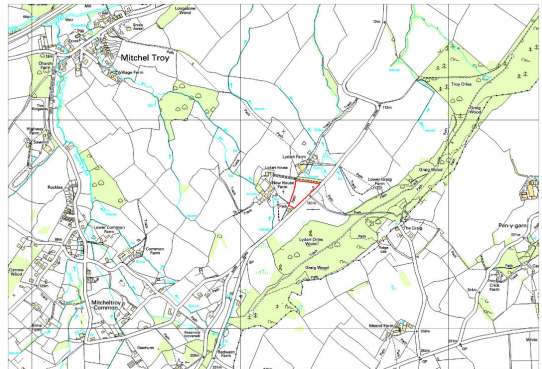

FULL DESCRIPTION OF SITE (including topography, adjacent land use, access and boundaries etc.):

The orchard is on rough grassland with patches of Nettles that slopes downwards in a generally northerly direction. It is largely surrounded by hedges and is stock-proof. The more steeply sloping higher ground towards the south-east of the site retains an old remnant orchard with just nine trees left (mostly Apple and one Pear) with many veteran tree features present in the trees. The lower ground at the northern end of the site has recently been planted with fifty fruit trees (mostly Apple and some Pear and Plum) of approximately twenty varieties.

- 5 or more cultivated fruit or nut trees, crown edges no more than 20m apart - **Y**

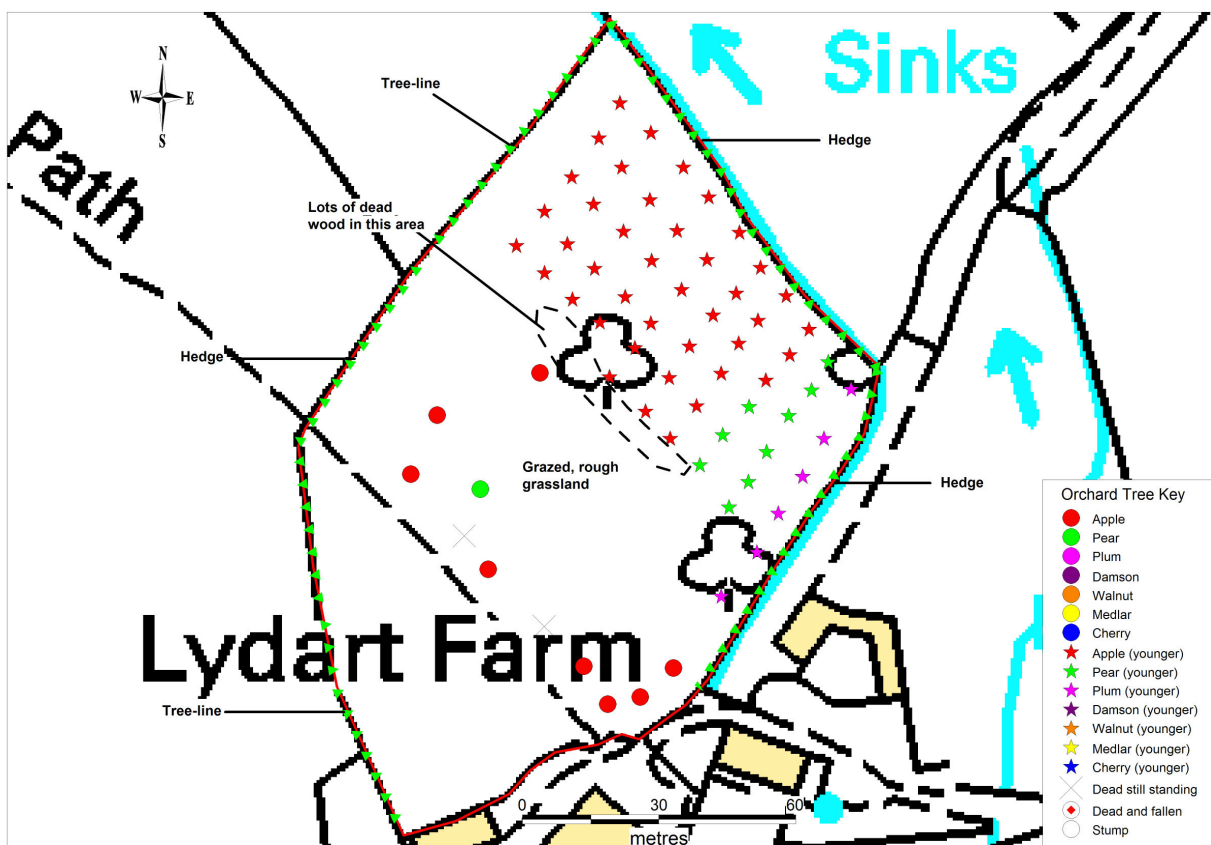
