FULL DESCRIPTION OF SITE (including topography, adjacent land use, access and boundaries etc.):

This orchard was part of a larger orchard that has been divided very recently into three separate parts with the middle section under new ownership/management. As a consequence this has been assessed separately. The orchard slopes downwards to the north and is on cattle grazed, improved grassland that is bordered by hedgerows to the north and south and a newly erected fence to the east. The garden of Newbold's Farm lies to the west. The number of older/veteran trees in this section of the orchard is less than the other two sections and they are spaced out (more than 20m apart). There is however a large dead but standing Pear tree and a nice partly hollow Apple together with new planting of approximately 40 Apple trees.

Orchard:

- 5 or more cultivated fruit or nut trees, crown edges no more than 20m apart – **Y (This would not be the case but new planting fills in the gaps)**
- Being of a traditional structure which may currently be or have been managed in a traditional way - **Y**

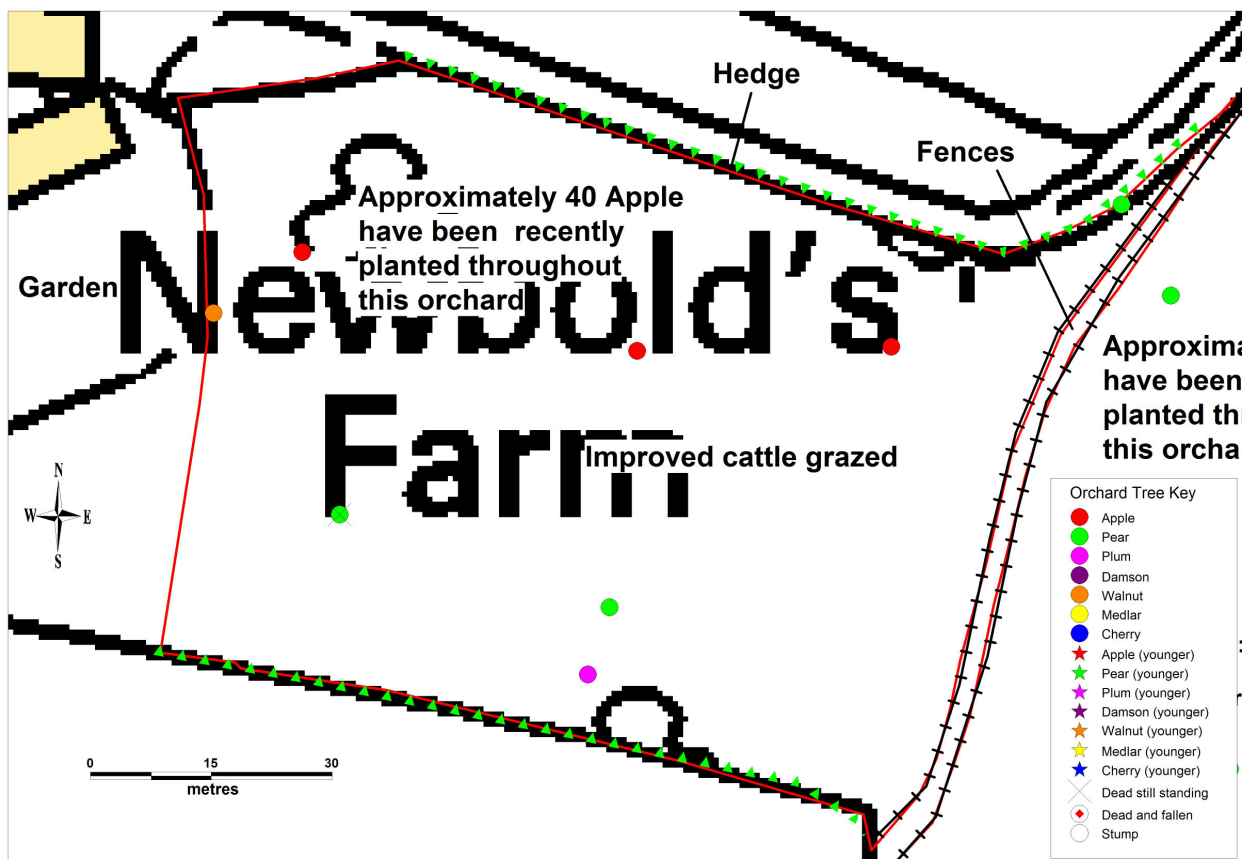
