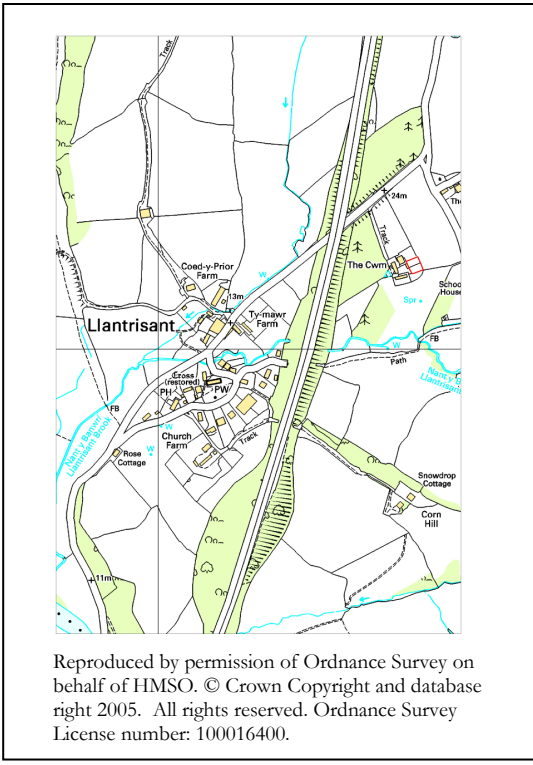

FULL DESCRIPTION OF SITE (including topography, adjacent land use, access and boundaries etc.):

This is a small orchard area that is basically just part of the garden/vegetable plot to The Cwm and is interspersed with other “ornamental” trees that are part of garden. There are lawned areas, vegetable beds and other cultivated areas. Hedgerows and walls surround the site. The orchard part contains a large/old Pear, a very old Plum and a large dead Apple (died 2012), most other trees appear more recent but are still reasonably old. As it is a garden it is kept tidy with dead wood removed.

- 5 or more cultivated fruit or nut trees, crown edges no more than 20m apart – **Y**

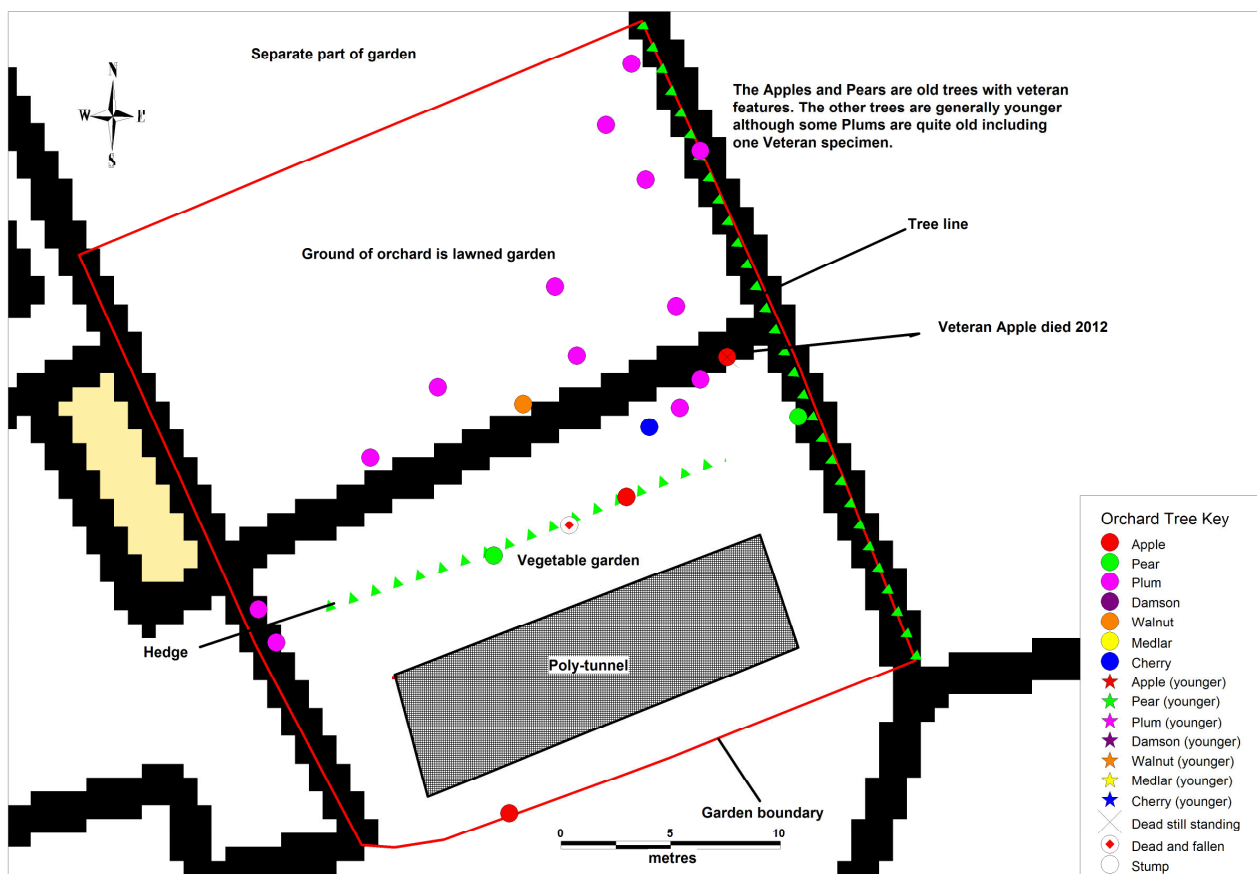
