

SITE OF IMPORTANCE FOR NATURE CONSERVATION

HAWTHORN CLOSE

Site Description:

Hawthorn close woodlands fit into the definition of semi-natural woodlands based on the species composition and cover. The upper canopy is primarily composed of Oak (Quercus spp), Ash (Fraxinus excelsior) and Sycamore (Acer pseudoplatanus) with estimated coverage of these major species at over 90%. The understory contains the same components, as well as Hawthorn (Crataegus monogyna), Hazel (Corylus avellana) and Holly(Ilex aquifolium). The streamside areas contain typical native wet woodland species, primarily Willow (Salix spp) and Alder (Alnus spp). The woodland has a complex multi layered structure with a varied age classes across the primary species.

This is an area of broadleaved woodland which forms part of the riparian corridor of the River Afan. The village of Cwmafan is on the North side of the river, sprawling further up the Afan valley to the east, and down towards Port Talbot in the west. Other sites of nature conservation interest in the vicinity include Cwmafan Coal Tip (NPTSINC068) approx 350m east of the site. These two sites are ecologically connected by the river and its scrubby riparian zone. It doesn't appear as though any management is undertaken in the woodland
