

SITE OF IMPORTANCE FOR NATURE CONSERVATION

LITTLE WARREN

Site Description:

A small area of sand dune supporting an important population of Matthiola sinnuata (Sea stock). The site is located at the southern end of the Aberafan seafront developments at the mouth of the River Afan. The dune's northern and eastern boundaries are adjacent to housing development whilst the southern and western boundaries grade to river mouth and sea shore. The Afan's estuary is also designated as a SINC (NPTSINC009). Baglan Bay dune system (NPTSINC006) is located at the northernmost end of this coastal stretch, with the vast development of Sandfields and Baglan Energy Park between them. The site is currently managed by The Wildlife Trusts of South and West Wales.

Qualifying features

H15:2 Coastal sand dune, together with associated slacks, seepages, grassland and scrub habitat S6 Vascular plants - (PS) Sea stock

Important species

Species recorded: Sea stock, Bulbous buttercup, Sea holly Habitat suitable for: Small blue, reptiles

Management Recommendations

The site is heavily used by walkers. Litter and dog waste are causing nutrient enrichment and therefore localised losses of characteristic dune species.

The promenade runs between the front of the system and the beach itself, curving around to the south-east. Along with the housing development to the north and east, this means that the system is encircled by hard surfacing. Sea level rise will squeeze this system against the development. If no land is provided to allow backwards movement then it is highly likely that the dunes will eventually be lost, along with the protection that they provide.
