

# LAND BEHIND MARIGOLD PLACE

#### Site Description:

An area of marshy grassland that is dominated by Purple Moor Grass with mosaics of wet heath and acid grassland. The former NRW plantation of Nant Melyn is to the south of the site, and the settlement of Blaendulais is at the northern boundary. The Dulais valley supports a number of important marshy grassland sites, several of which are designated as SINCS for example Treforgan (NPTSINC055), School Road (NPTSINC070) and Rhos Common (NPTSINC035) are located down the valley, whilst Adjacent to Gors Llwyn (NPTSINC075), Intervalley Road (NPTSINC076), and Banwen Pond (NPTSINC077) are up the valley to the east. In combination, these sites provide a stepping stone of important habitat for a number of species.

## **Management Recommendations**

This site should be grazed at a conservation grazing level; ideally a stocking density of approximately 0.2 livestock units/hectare/year to result in an average sward height with no more than 10% of the sward height under 12cm.
