# **ST DAVID'S GRAVEYARD**

#### Site Description:

A churchyard site to the south-west of Resolven in the Neath Valley at an elevation of 30m asl, the underlying geology comprising of the South Wales Upper Coal Measures Formation, overlain with glaciofluvial deposits of Devensian sand and gravel and subsequently alluvium. The primary habitats on site are semi-natural woodland elements and semi-improved grassland. Ownership is unknown and management is through occasional cutting/strimming. Recorded taxa include 144 vascular plants, 28 bryophytes, 18 birds, 1 fungus, 1 lichen and 8 invertebrates

### **Qualifying features**

H1:3 Native woodland - mix of native tree species inc 5 indicators H5:1 lowland meadows 10/8

#### **Important species**

S7: Bullfinch, House Sparrow

Woodland Indicators: Barren Strawberry, Broad-leaved Helleborine, Remote Sedge, Common Figwort, Hard Fern, Oppositeleaved Golden-saxifrage, Pignut, Soft Shield-fern, Yew

Grassland Indicators: Common Bird's-foot-trefoil, Common Cat's-ear, Common Knapweed, Cuckoo-flower, Imperforate St John's-wort, Pignut, Red Clover, Squirreltail Fescue, Tufted Vetch, Wild Angelica

#### **Management Recommendations**

Non-intervention of the larger trees and associated field layer will ensure the natural development of woodland, though periodic checks should be made to assess over-dominance by non-natives and or bramble. An annual cut of the grassy areas will ensure the habitat is kept in favourable condition, ideally all arising should be removed.
