Site Description:

A north-facing slope in the Pelenna Valley lying to the east of Efail-fach. The elevation ranges from 110m to 147m asl, the underlying geology comprising of the South Wales Upper Coal Measures Formation in parts overlain by glacial till. The primary habitat is degraded blanket mire with Purple Moor-grass and Rush-pasture, drier areas supporting acid grassland. Ownership is unknown, but low-intensity sheep grazing maintains the vegetation if reasonably good condition. Recorded taxa include 93 vascular plants, 25 bryophytes, 6 birds, 3 lichens and 1 invertebrate

Management Recommendations

Continuation of low level grazing by sheep will ensure the habitat is kept in favourable condition, though light pony or cattle grazing could be considered for use to help diversify the sward.
